

## Payment Options, Course Fees and Subsidies (August 2025)

Fees cover enrolment, tuition, course materials, textbooks, and other services related to your training and assessment. Please be aware that fees and subsidies are subject to change. For verification, contact our office at [admin@ruralbiztraining.com.au](mailto:admin@ruralbiztraining.com.au).

### Payment Options

#### 1. Upfront Payment

- Individual students can pay up to \$1,500 of their course fee up-front.
- Employers or organisations can pay up to 100% of a student's course fee up-front if the student is an employee or member.

#### 2. Payment plan

- Payments can be made weekly, fortnightly, monthly, or quarterly via direct debit from a nominated bank account or credit card throughout your enrolment. Payment plans are administered by DebitSuccess - [www.debitsuccess.com.au](http://www.debitsuccess.com.au)
- Fees: \$13.64 establishment fee + administration charge (Credit Card: 5.5%, Direct Debit: 4.5%). The establishment fee is paid in your first instalment and the administration fee becomes part of your scheduled deduction.

#### 3. Vet Student Loans – all states

VET Student Loans are Australian Government loans that help eligible students pay for all, or part of, their tuition fees for higher-level VET courses (Diploma and Advanced Diploma) undertaken at approved providers. Eligible courses are:

- AHC50122 Diploma of Agriculture
- AHC50422 Diploma of Horticulture Management
- AHC51222 Diploma of Community Group Coordination and Facilitation
- AHC51422 Diploma of Agribusiness Management
- AHC60319 Advanced Diploma of Agribusiness Management

A VET student loan gives rise to a VETSL debt that continues to be a debt due to the Commonwealth until it is repaid. The 2025 VSL loan cap for these courses is \$18,838. ## Fees & Subsidies by Region

### New South Wales

Students who live and work in NSW may be eligible for a course fee subsidy from the NSW Government. NSW Smart and Skilled funding is available for most residents.

Eligibility criteria includes:

- being 15 years or older
- having left school
- living or working in NSW
- being an Australian citizen, permanent resident, humanitarian visa holder, or New Zealand citizen.
