Course costs will be provided to you during the enrolment process and are subject to unit selection.

Subsidies are periodically available under the NSW Government's AgSkilled Program for eligible NSW residents. NSW Participants who have not previously received NSW Smart & Skilled funding to complete a course may be eligible for FEE-FREE training under the AgSkilled program, subject to budget allocation.

NSW Smart & Skilled eligibility requirements:

- Aged 15 years or older
- No longer enrolled in secondary school
- Living or working in NSW
- An Australian citizen, Australian permanent resident, Australian permanent humanitarian visa holder or New Zealand citizen
- have not already completed or be enrolled in a Certificate IV level or higher qualification that has been subsidised by the NSW government.
